MESSAGE FRM DEREK: Many of you recently received an email from our vendor, GetQuorum, entitled “**WIGGINS LAKES & PRESERVE ASSOCIATION, INC. – Submit your Vote!**” We understand this message has caused some confusion, and I’d like to take a moment to clarify its purpose.

First and most importantly: **there is no vote or election this year** for the Annual Meeting. The email wording was standard language generated by GetQuorum and does *not* mean that a vote is taking place. What *is* required, however, is the submission of an **Annual Meeting proxy**.

Why is a proxy needed?

The Association must meet a quorum requirement in order to officially hold the Annual Meeting. Submitting your proxy helps ensure we meet that requirement—even if you plan to attend the meeting in person. **All members should submit a proxy**, whether or not they plan to attend.

About the “Proxyholder” Section: There has also been some confusion regarding the proxyholder portion of the form. Please note:

- The proxyholder can be anyone you choose
- For this particular meeting, the proxyholder is largely irrelevant, since there are no votes or elections being conducted
- The proxy is simply a formality to confirm representation for quorum purposes

If you have not yet submitted your proxy, we encourage you to do so at your earliest convenience. Paper copies are also available here in my office! As always, thank you for your cooperation and for being an engaged part of the Wiggins Lakes and Preserve community.
