

MESSAGE FROM DEREK: I would like to thank everyone who attended our Board Meeting on July 30 either in person or via zoom. By Monday, Aug. 4, I will have uploaded the agenda, the minutes, and the Board PowerPoint presentation which can be found in the Owners' Section on the website. A link to the video about the Straight Line/Cash Flow methods for funding Reserves that wouldn't play during the meeting is included in the PowerPoint. This is the graph from the PowerPoint that wouldn't project. You can see that the two biggest issues are Property and Flood Insurance and Reserves. Our location, in Florida near the water, impacts the insurance cost. And by law, Reserves must be fully funded. Important to remember, there are FOUR SEPARATE RESERVES for Wiggins: Commons, P1, P2, and Lakes. Reserve funding cannot be moved from one Association to another; that is against the law. The Board continues to explore areas and methods we can employ to lower costs.



- **PICKLEBALL NEWS** During the summer rainy season, we must take down and store the pickleball nets so they don't rust out. However, occasionally owners come to Wiggins in the summer and would love to play. So, thanks to our Social Committee, we have now purchased one portable pickleball net. It's the SLK Prime Portable Net by Selkirk. It weights 19 lbs, is in a carry case, and is easily assembled. There are assembly directions included, and there is a video on the Selkirk website demonstrating the net assembly that is very helpful. This portable net is now kept in the Clubhouse and must be signed out with Derek. It must be taken down after each use, it cannot be left out on

Around us we see Wiggins Pass Rd, Delnor Wiggins State Park, Wiggins Bay, and of course Wiggins Lakes & Preserve. Who is this Wiggins?

Joe Wiggins was the first homesteader in the area of Wiggins Pass. He traded goods with the Seminoles and the settlers. He opened a trading post at the Pass and operated an apiary.
